Flying Club

WHAT: Dues, paid directly to the landlord, policy for **new, first time, Renewal, OPEN full category** members. *The facility maintenance fee is separate and determined annually. It will not factor in the pro-ratio formula.*

WHY: To clarify the length of time your membership is valid, according to the date of your dues payment. This is necessary since ERC membership works on a calendar year basis starting January 1st, rather than the date of your dues payment.

HOW: **FIRST QUARTER:** If you join ERC as a first time, new member from January 1st through March 31st, you will do so at the full, open rate.

SECOND QUARTER: If you join ERC as a first time, new member from April 1st through June 30th, you will pay the full, open rate. The following year, your renewal notice will reflect a 25% reduction in dues.

THIRD QUARTER: If you join ERC as a first time, new member from July 1st through September 30th, you will pay the full, open rate. The following year, your renewal notice will reflect a 50% reduction in dues.

FOURTH QUARTER: If you join ERC as a first time, new member from October 1st through December 31st, you will pay the full open rate. **You will receive membership for the remainder of that year, plus membership for the following year. AMA must be valid for the following year.**

Memberships *Full membership* is one member joining the club over the age of 19 with a valid AMA #.
Family membership is Spouse and/or additional family members, living at home under the age of 19, with valid AMA # or immediate family members over the age of 18 still living at home and attending school full time.
Junior membership is a member under the age of 19 years of age with a valid AMA # with no adult family member flying.
Renewing members if you are renewing prior to December 31st for the new year your dues are what was emailed or mailed to you. If your membership has lapsed for one or more years you Fill out a new membership application and all new member requirements must be met to include Initiation fee, facility fee and the above pro-rating for the subsequent year.

ERC Field Rules Changed January 18, 2017

- * **The AMA Safety Code is in force at all times.**
- * **Prop ripping is not allowed and can be a reason for expulsion.**
- * **Aircraft larger than ¼ scale will do all fly-bys and stalled wing maneuvers past the center line of the field.**
- * **The field frequency control board will be used at all times when using 72mHz. You must pin your channel before turning on your transmitter. If you cause a model mishap, because you turned on a transmitter and you don't have a pin on the control board, you are liable for all damages.**
- * **Pilot's using 2.4 GHz transmitters are not required to pin the frequency control board unless required by an event CD.**
- * **All pilots must have a current AMA card to fly. The exception will be pilots in the club Intro Pilot Program.**
- * **Etowah R/C Club Members are required to display their membership card while at the field.**
- * **When more than one model is flying, there should be a spotter to watch out for potential hazards, the pilots may not see.**
- * **When a spotter is not available, pilots should stand close enough together to be able to hear warning shouts.**
- * **Models shall not be taxied into the pits.**
- * **Pilots will stand behind the flight line barrier fence while flying.**
- * **No R/C Flying is allowed in the pit or parking areas.**
- * **While control line models are being flown, all vehicles must be a minimum of 10 feet from the flight path.**
- * **Announce to others whenever you step out onto the active runway.**
- * **The flight pattern will generally be controlled by wind direction. All flyers in the air will adjust to one pattern.**
- * **There should be no more than four models in the air at the same time.**
- * **Take your trash out with you when you leave. If you smoke do not throw butts on the ground.**
- * **Engines will not exceed 102 DB measured at 10 feet.**
- * **Guest pilots must be accompanied by a club member.**
- * **No internal combustion engines are to be operated before 10:00AM on Sunday's.**
